

General Rules & Guidelines to be adhered in the Institute

- The students must wear complete uniform and I cards.
- 2. Notice on the notice boards can be displayed only under the signature of the Director.
- 3. Proper discipline should be maintained inside and outside the classes. Do not shout and call each other loudly in the college campus
- Absence from Sessional / Pre University examinations / Guest Lecture / Placement Session is punishable with a fine of 50/per subject per instance.
- 5. Use of mobile phones is prohibited.
- 6. No student will damage any property of the Institute, for example writing on furniture and walls of the college. Anyone found guilty will be severely dealt with and will have to pay the costs/damages/fine.
- 7. No student will leave the campus during working hours without the written permission of the Director.
- 8. Every student is required to fill in an ELECTION ID form for the purpose of VOTER I-CARD. (If not already registered)
- 9. Wearing of HELMET is compulsory for students coming to institute on two wheelers.
- 10. Vehicles should be parked only at the designated parking only. Do not park your vehicles along with college boundary.
- 11. Smoking, consuming Alcohol or any other intoxicant and littering are strictly banned in the Institute. Strict disciplinary action will be taken against the defaulters.
- 12. Students are not allowed to bring their four-wheelers to the Institute.
- 13. Fee collection is through Bank (OBC-PNB MLN College Branch/HDFC Bank). Students can submit Cash/Bank Draft/ Debit-Credit Card after taking pay-in slip from the Accounts Office of the Institute.
- 14. Fees must be paid by due date, otherwise a late fee fine will be charged.
- 15. Absence from the Institute will not be accepted as an excuse for non-payment of dues.
- 16. Fee will be refunded strictly as per the rules of State Fee Committee.
- 17. The name of a student, who remains absent for five working days consecutively, will be struck off. Student will be required to seek Readmission as per rules.
- 18. Students residing in the Institute Hostel must pay their dues/mess charges regularly, otherwise their names will be struck off from the Institute rolls and they shall be asked to vacate the hostel immediately.
- 19. Application for leave must be submitted online through ERP.
- 20. The students who remain, on leave or absent for any reason, should note that their leave period lectures will not be counted for condoning the shortage of lectures.
- 21. A student wishing to withdraw from the Institute must submit an application to the Director signed by his/her parent or guardian along with "No dues" certificate. The student is liable to pay the Institute dues until his/her name is formally withdrawn.
- 22. Any grievances (in general) can be addressed at registry.grievance@timt.ac.in
- 23. All complaints relating to Sexual Harassment should be intimated to Internal Complaints Committee for redressal.
- 24. The academic session commences in 2nd week of July every year.
- 25. Do not litter your class-rooms and campus with wrappers, papers and polythenes. Use dustbins which are available at various places in the college.

PLACEMENT - PROCESS & POLICY

The Training & Placement office at TIMT aims at providing placement assistance to graduating students. The T&P office endeavors to bring together the students and the potential employing organizations and facilitate the interaction between the two. The Training & Placement cell in the institute plays a pivotal role in counseling and guiding the students for their successful career placement which is a crucial interface between the stages of academic program of the students and their entry into suitable employment.

Eligibility

All graduating students shall be eligible to receive placement assistance, unless otherwise debarred from receiving such assistance on account of:

- · Non-payment of fees or any other dues and /or
- Non completion of Summer Internship Programme/ other academic requirements.
- Breach of discipline and general misconduct
- Having opted out or having been declared as 'deemed to have opted out'.

During Placement Assistance, Companies would either come for the Campus and/ or the students would be required to move to organizations' premises. This assistance is provided up to May 31 every year to the eligible graduating students.

PLACEMENT ASSISTANCE

Registration for Placement Assistance

All students seeking Placement Assistance are required to register, with the help of Placement Coordinator, by signing an undertaking in the prescribed format placed at T&P Office. Students, who want to opt out of Placement Assistance, shall give an undertaking to the Director in the prescribed format. The student should register for Placement Assistance Latest by September 10

APPLICATION PROCEDURE

- The RFPs (Requisitions for Final Placements) will be announced by T& P through Placement Notices under the Quality Format- QF/INT/008/B specifying the Job Descriptions and Job Specifications. The list of all the eligible students (short listed against the criteria specified by the organizations in Job Specifications) will be forwarded to the respective organizations through T&P.
- No applications from students in response to the press advertisements or to the organizations which have not notified the T&P about their requirements shall be forwarded by the T&P.
- However, students are free to correspond directly with the organizations in response to such advertisements.
- If these organizations announce jobs to the institute's T&P at a later date, then the students should inform the T&P about their having earlier applied for positions in these organizations.
- If a Company has approached the T&P or is in the process of approaching the T&P for placements, no student shall approach any of these Companies on their own, except through T&P.
- Students are advised to be equipped with sufficient copies of the customized CV/ Résumé tailored to the Job description and Job specifications rendered through notices, Passport size photographs along with the Résumé folder including all testimonials and allied prerequisites so as to be prepared for the placement drives.
- Students may apply to organizations only against functional positions specified through RFPs. The T&P shall not entertain applications/ resumes of students who want to apply for hypothetical positions or for functional areas not announced.

SHORT LISTING

 Companies may do short listing of students themselves on the basis of information supplied by the students in their registration profile or CVs/ Résumés.

- In case a company insists on short listing to be done
 by the Institute without explicitly citing any criteria, it
 will be done on the basis of Criteria determined by
 the Director.
- Hence, all the interested students may not get short listed.

INTERVIEW PROCEDURE

- Interview schedules shall be decided by the T&P in consultation with the Company executives and would be communicated to the students through Placement Notices under the Quality Format-QF/INT/008/B.
- · Students shall,
- Keep record of organizations and positions for which they apply.
- Keep notes on the job details announced. These are useful at the time of interview.
- Prepare completely for attending the various Written Tests, Group Discussions and Interviews, particularly in respect of the specific company for which they are appearing.
- Students shall not, at the time of interview, negotiate with the employer about salary and terms of employment, diverse from what is communicated to them through notices and/ or during scouting by organizations, unless the announcement specifies that the salary is negotiable.
- While attending interviews, students must be punctual and report in complete uniform. They must observe adhere to all code of conduct rules specified by T&P. While answering questions in the interview, students should observe decorum. They should abstain from making any kind of derogatory remarks about others. The impact of the behavior exhibited by the interviewees has at times reduced the opportunities available to future batches of students. Irresponsible behavior, such as efforts to "market" oneself, derogatory remarks about other candidates or the institute, negotiations other than those purported under the due process, will be seriously viewed. Such students may be denied further Placement Assistance.
- Keeping the Corporate organizations' convenience in view, selection processes may take place in any city/town in the states or nearby metros. The students may be required to travel and attend the same. The T&P shall pass on the information received from the organization to the concerned students. The students are expected to make their own travel and other arrangements.

WITHDRAWAL PROCEDURE

- Students having once nominated to an organization shall not withdraw from the selection procedure at any stage, unless they have a final offer from another organization under the confines of the due process. It is presumed that students would apply for a position after careful consideration of all the relevant aspects.
- If a student does not appear for interview after nomination, he/she is deemed to have withdrawn.
- Only in very exceptional circumstances, shall a student be permitted to withdraw from the selection procedure of attending preliminary interview, if short listed by the organization, i.e. if he/she explains in writing to the Director, full reasons for and the unusual circumstances that need his/her withdrawal, and that the Director accepts these as truly exceptional and legitimate grounds for withdrawal.
- Subject to permission as above, a student can withdraw a maximum three times from the selection processes provided by the institute. The moment he/she refuses to sit for the interview for the third time, he will be out of the Placement Assistance.

OFFERS

- Offer stands for the placement selection letter issued by the Company in composite letter form for a set of students or individual letters in the name of students.
- Students are permitted to receive a maximum of one job offer only. A student shall be allowed to go through the selection processes, based on specified criteria, till he/she secures a job offer.
- Students shall not request any organization to keep an offer pending. Any such request shall be considered as a serious breach of the placement norms. They shall also not request their future employers to allow extension of deadline for communication of their decision regarding offers made by an organization. Such a job offer shall be treated as a final offer and the student shall not be eligible for placement assistance, thereafter.
- However, such a student shall be permitted to appear in further interview(s), only in respect to the organization(s) offering a relative hike of more than 30% in the base component of compensation. In addition, in case of higher CTC, if the component of variable pay is more than 70% of the fixed then the student may be given a chance to appear in the next campus as per rules.
- All offers of a particular company shall be announced at the end of the selection process of that company. All offers shall be routed through the T&P only. If the student is not selected by five companies, he will be out of the Placements Process.
- Students whose attendance will be less than 80% in PDP/Lifelong skills/Language Lab classes shall not be eligible to participate in placement process.

END OF PLACEMENT ASSISTANCE

 The Placement Assistance ends by June 30 or cent percent placement of graduating students which ever is earlier.

GENERAL GUIDELINES

- T&P shall aim to provide placement assistance for all graduating students. Placement is a privilege extended to the students not a right.
- These guidelines are framed to ensure equality and fairness of opportunity to all the students. All students who opt for placement through the T&P shall abide by the guidelines prescribed herein above.
- Any breach of rules specified above by any student, shall be taken up seriously by the T&P who in turn will view the matter and take action against the student, as it may deem fit.
- Students shall not try to gain unauthorized access to communications regarding placements from the Institute's administrative system like the T&P, Dispatch and Fax office.
- If, in the judgment of the T&P, a student has behaved in a manner unbecoming of a graduate of the institute, the T&P would be free to impose a suitable penalty to the extent of withdrawing further placement assistance to the concerned student and taking other action as necessary.
- The T&P reserves the right of modifying any or all of the above norms and/or stipulating additional norms for placement which, in its judgment and discretion, are likely to benefit the students, immediately or in the future.
- Final authority in case of any dispute would be Director and his decision will be final.

It will be in the interest of all the stakeholders in the Final Placement Process, to adhere and support the contents of the SOP for Placements, as successful completion of this programme will mutually benefit both TIMT and the students.




